SVSU Parcel Data Request:

Bridget Smith, Assistant Director of Community Development for Saginaw Township, presented a letter from SVSU Economics Professor Micah DelVecchio, requesting data from the Authority to assist his class in comparing land values, employment, and personal property for an economic presentation as well as to apply for a regional grant. Discussion followed.

It was noted that SVSU has been offered a non-profit partnership with SAGA for \$3,000 in the past and they have declined. Hoffman stated that the Authority has allowed sharing of data with SVSU on a case by case basis. It was moved by Taylor and supported by Moore to grant the data access to Professor DelVecchio with the contingency that the Authority have full access to his findings.

SAGA LiDAR Acquisition:

Discussion was held on the \$65,000 proposal from Kucera for obtaining the raw LiDAR data in the spring fly-over. The actual processing of the data could be done for a lower cost by Spicer Group.

It was moved by McGill and supported by Moore to have Kucera gather the one foot contour LiDAR data in the 2015 fly over for an additional cost of \$65,000 (shared 50/50 with SCPWC) and have Spicer Group process the data at a to-be-determined cost (with the option of paying for Spicer's services over multiple years). It was noted that the LiDAR data would be available for public access.
