Staff Update:

Web Update: Hoffman reported that there were a few minor issues with certain properties not showing up on the SAGA website. Mike McGibney was working with Dan Sherman on correcting those issues.

Discussion was held on the website migration and Jeruski informed the members that BS&A was testing the script for the property data; however, they have not provided a completion date. Hoffman reported that the list of layers for the mapping portion of the site had been submitted to Amalgam and they are currently processing three years' worth of aerial images and also have not given a completion date. Grose reminded everyone that the deadline to update the site was October 1. Hoffman stated that the current site would stay active for at least a couple of months while the new site was being completed. He would get the cost from City of Saginaw to keep the current site live and bring back to the membership.

Hoffman stated that SAGA's website domain registration would be expiring in January. The cost to renew for 6 months was \$210.

E-911: Hoffman stated that Motorola was moving to a new version of software and there would be training provided in November.

Utility Project Update:

NRCS LiDAR Grant Update:

Brian Wendling gave an update on the status of the grant application. All required forms had been submitted. The total grant amount (if awarded) would be \$102,690 (50/50 split). Wendling did not have a timeline. Discussion followed.
